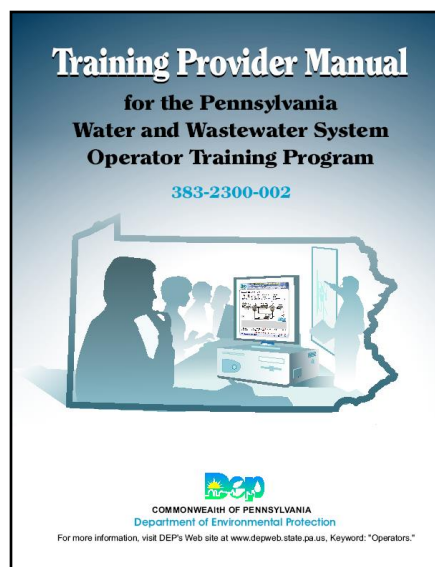

Training Approval Process

Needs Assessment

- W & WW Technical topics
- Related Topics
 - Safety, computer, math, chemistry, electrical, mechanical, pumps/motors, plumbing, watershed, etc....



Training Approval Process

Ways for operators to obtain Credit

- Classroom training
- Distance education
 - Web-based, computer-based, correspondence
- Structured on-site training
- Vendor training
- Association conferences



Training Approval Process

- Approval process ensures:
 - Training is relevant
 - Training is effective
 - Quality training
 - Enough training available
- No Rubber Stamping !
- Only Pa.-Approved Training Counts!



Training Approval Process

Pa. Continuing Education Credit “Contact Hours”

- 1 contact hour = .1 CEU
- 1 CEU = 10 contact hours
- 1 College credit = 15 contact hours



Training Approval Process

Definitions

- **Provider** - Entity providing training
- **Sponsor** – DEP-approved provider of water or wastewater training



Training Approval Process

Training Course – Formalized program of organized instruction that meets Pa. DEP course guidelines

- Helps operator do job
- Includes:
 - **Content**
 - **Delivery (sponsor)**



Training Approval Process

Training Approval Development

- *Pa Op Cert Act of 2002 - DEP power & duty to:*
 - *Approve, disapprove, suspend, revoke training*
 - *Develop guidelines*



Training Approval Process

■ Process

1. Approve providers – Sponsors
 - Eligible to submit courses for approval
 - Option – Accredited training program
 - Eligible for streamlined approval of courses
2. Approve Courses

No application fees



Training Approval Process

Sponsor Standards & Responsibilities

- Administrative services
- Use qualified instructors
- Adult learning methods
- Appropriate advertising
- Attendance tracking
- Assessment methods



Training Approval Process

Sponsor Standards & Responsibilities

- Course completion
- Educational resources
- Physical facilities
- Records – 3 years
- Course evaluation
- Internal audit



Training Approval Process

Sponsor Standards & Responsibilities

- Consider evaluations and audits
- Conform to ADA
- Allow DEP to review/audit courses, records, instructor qualifications.
- Technology-based Training (Web-based)
 - Administration
 - Technical support
- DEP reporting



Training Approval Process

Sponsor Reporting Requirements

- Pa. Operator Roster Reports
(Allows DEP to automatically track operator credits)
 - Sponsor name and ID
 - Course ID, name and date

Training Approval Process

Course Guidelines

- Proper calculation of contact hours
 - Breaks, mealtimes do not count
 - Homework, reading “generally” not counted
- Minimum – ½ hour course
- Max 8 hours in one day
- 85% min attendance for completion



Training Approval Process

Course Guidelines

- Assessment for completion (tests, exercises, project, participant interaction)
 - Based on objectives
- Audio/video – contribute to objectives



Training Approval Process

Course Guidelines

- Learning experience must be:

■ Open	■ Relevant
■ Current	■ Meaningful
■ Accurate	■ Rewarding
■ Efficient	■ Interactive/Involving
■ Presentable	



Training Approval Process

Course Guidelines

- Logical sequence
- Handouts, visuals – relevant/readable
- Qualified instructors
- Content achieve objectives
- Presented in reasonable time frame
- Intent not to promote specific products
- Adult learning concepts
- Evaluation by participants



Training Approval Process

Course Guidelines

- Technology-Based Training
 - Web-based Training Courses
 - Presentation / Application / Feedback
 - Must include interactivity
 - e-Learning Courses
 - On-Line Courses



Training Approval Process

Course Guidelines

- Technology-Based Training
 - Must include assessment
 - Clear & consistent instructions
 - Average pace match credit value
 - Technical support
 - Learner controllable
 - Graphics, audio/video support objectives
 - Content is king
 - Interactivity encouraged



Training Approval Process

Other Features of Approval Process

- Water and Wastewater Industry Conferences
- Certificate/Associates Degree Program
- Post Presentation Credit
- Retroactive Award of Credit (if course approved within operator's cycle)



Training Approval Process

Water and Wastewater Industry Conferences

- 1/2 day = 2.5 hours = 1 contact hour
- Must be a Pa. DEP-approved sponsor
- Conference Notification Form
- Must track and report for each half-day
- May include approved courses for credit



Certificate & Degree Programs

- Reduces required operating experience
- Program for drinking water, wastewater, or both
- DEP-approved courses
 - Certificate program – 180 hours (12 credits)
 - Associates Degree – 360 hours (24 credits)
 - Water/wastewater program – courses approved for both apply to both



Training Approval Process

Post Presentation Credit

- Courses not previously approved
- Request by operator for credit (apply NLT 90 days after end of cycle)
- Not applicable to conferences
- No guarantees for operator



Training Approval Process

Retroactive Award of Credit

- Provider unaware of water and wastewater continuing education
- Sponsor and course must be approved before end of operator's expiration date
- Prevents multiple post presentation requests.



Training Approval Process

Early skeptics said:

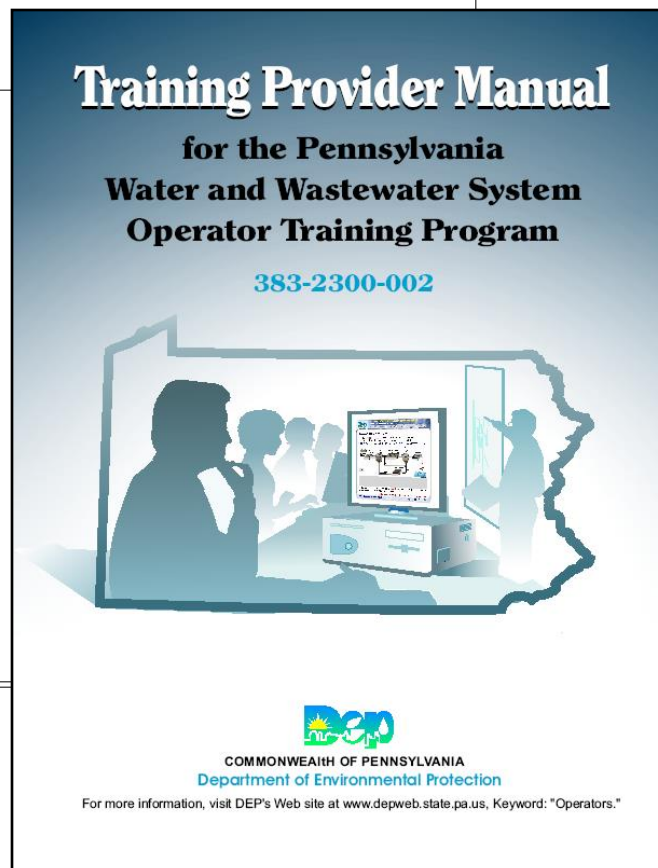
- *Too onerous*
